# **Privacy Policy**

#### Introduction

In connection with your interest in original video content, contained on the website https:// ada.productions (hereinafter referred to as the «Website»), and using of the Content as indicated in the License Agreement, contained at https://ada.productions we outline ongoing obligations of LOOKNESS VENTURES LIMITED. (hereinafter referred to as the «Company») to you in respect of how the Company manages your Personal Information. For the Company, the privacy and security of our users and (hereinafter sometimes also referred to as the «Users» or «You») are of paramount importance. The Company respects the privacy of all users of our Website and the Content. The Company ensures that personal information of the Users will be treated confidentially. This Privacy Policy applies to using of the Content, licensed to you by the Company. The Company is not responsible for the privacy policy of other websites and sources. By using the Website you indicate that you accept the Privacy Policy. The information provided on the Website is not intended for distribution to, or use by, any person or entity in any jurisdiction or country where such distribution or using would be contrary to any law or regulations.

#### **Defined Terms**

The following terms used in this Privacy Policy have defined meanings.

- Personal Information. Any data about an identified or identifiable individual, including data that identifies an individual or that could be used to identify, locate, track, or contact an individual. Personal information includes both directly identifiable information such as a name, identification number or unique job title, and indirectly identifiable information such as date of birth, unique mobile or wearable device identifier, e-mail, telephone number as well as key-coded data.
- **Third party.** Any legal entity, association or person that is not owned by the Company or in which the Company does not have a controlling interest.



#### Controller

The Company processes Personal Information both as a Processor and as a Controller. The Company adheres to the Directive of 1995 and the GDPR from May 25th, 2018 when processes all data provided by users from the European Economic Area (EEA) only.

#### **Personal Information and Details**

Personal Information may be obtained in many ways including correspondence, by telephone and fax, by e-mail, via the Website, from media and publications, from other publicly available sources, and may probably be automatically collected. For the purposes of this Privacy Policy, there are two types of Personal Information: Information You Provide Us Directly and Information Collected Using Cookies and Other Data Collection Technologies. The Company may obtain the information, voluntarily provided by you to the third parties, upon your prior consent.

The Company doesn't guarantee website links or policy of authorized third parties. # Disclosure of Personal Information. How We Share Your Information

We may disclose your personal information:

- As required by law (e.g., in connection with any legal process). To the extent we are legally permitted to do so, we will take commercially reasonable steps to notify you in the event that we are required to provide your personal information to third parties as part of a legal process. Company also may be required to disclose personal information. in response to lawful requests by public authorities, including requests from national security or law enforcement authorities.
- When we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a written government request.
- If Company becomes involved in a merger, acquisition, or any form of sale of some or all of its assets. In the event of a merger, acquisition, or any form of sale of some or all of Company's assets, we will ensure that the acquiring organization agrees to protect personal information in accordance with the commitments we have made in this Privacy Policy, that the acquiring organization will provide notice before personal information, customer information, or business information becomes subject to a different privacy policy (privacy notice).
- To any other third party only with your prior consent to do so.

We will share your personal information with third parties only in the ways that are described in this Privacy Policy. We do not otherwise share your personal information with third parties.

#### **Security of Personal Information**

Safeguarding the information you give us or we receive about you through the Website is a priority for the Company. Your Personal Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification or disclosure. The Company has taken steps to ensure the ongoing confidentiality, integrity, availability, and resilience of systems and services processing personal information, and will restore the availability and access to information in a timely manner in the event of a physical or technical incident.



When your Personal Information is no longer needed for the purpose for which it was obtained, the Company will take reasonable steps to destroy or permanently de-identify your Personal Information.
